## Welcome remarks & introductions:

Prior to the meeting Richard Murray shared that SMDP came up quite a bit at PHARMA. PHARMA is having discussions about possibly having a fellowship to help candidates gain additional training in regulatory science. SMDP was mentioned as a positive program. Richard asked if Scott had met Ilene Cannon. Scott stated that he had not but that Steve Ubl has been wanting to connect her with ICPD.

Scott May welcomed everyone to the call for the 2017 Modules for Innovative & Diverse Leaders (MIDL) Advisory Committee meeting. Scott advised the advisory group how they could locate the supporting documents on the committee page by visiting the ICPD website (icpdprograms.org), under the drop-down menu on the top right (Committees). Scott reviewed the agenda for the meeting. Scott then introduced everyone on the call and announced the excused absences.

## **Overview of MIDL**

• Program Goals

The primary goal for participants is to prepare them for a senior leadership role in industry. For the sponsoring organizations, the goal is to provide an opportunity to engage their senior leaders with emerging leaders in the industry as well as provide them with access to talent for possible recruitment purposes



<u>Virtual Participation</u>

The program is structured as a one day introductory session followed by remote work. The remote work is conducted using Webinars and a web portal. The portal will support the virtual work of the participants.

• Participants

The participants are all ethnically diverse, have a minimum of five years work experience. They can be working in industry or also other areas such as public/government sector or academia.

Industry Coaches

The industry coaches are senior leaders from our sponsoring companies. Scott asked Fernando if he had been to the MIDL website recently. Fernando replied that he hadn't. Scott then led the attendees to the new portal that we are launching.

## **Current Programming**

- Launch of MIDL Portal the portal will go live November 15, 2017
  - We have had under development a new version of the mentoring portal for the MIDL Candidates. It is scheduled to be launched for early next week. The plan is to go live on November 15, 2017. Elisabeth later added that this is a new program. We are looking to engage and have the coaches continue to interact with the participants. This program is about grooming future leaders. The participants will be able to post questions and have the coaches answer them. She mentioned that we will be looking to the committee for suggestions. Scott then proposed at the next call that we give a demo of the new portal. Walter requested that we see if any of the first participants have been promoted since the program. Fernando added that as a participant he is in the process of speaking with HR on that very thing and how he was able to use the information from Korn Ferry and the other information at the program to help him in this process.
- Modules & Webinars

These will be released through the portal. The time table will be announced on the portal as well November 15<sup>th</sup>. Elisabeth added that the current group will continue to participate in the program when the new cohort joins. Everyone will be able to participate in the modules and webinars.

## Planning for the 2017 MIDL training session (February 27 in Philadelphia)

The committee has decided to offer only one MIDL Workshop per year. It will be once again held in Philadelphia. Scott informed the committee that Dustie is working on getting the same venue at The Hub.

• <u>Participants (application deadline January 10) and Industry Coach recruitment</u> There were several people that applied for the fall program that was postponed. Those applicants have now applied for the February program. Scott requested that if the committee members have anyone in mind for the program that they send them to the website so they can apply.



• Program agenda, venue and speakers/coaches

J&J has already started to identify coaches. Elisabeth mentioned that we would like to model the program after the one that was held in February.

We received positive feedback that the program was spot-on. Scott added that there is a sample agenda on the committee page. Walter asked if there is a deadline for when the speakers and coaches need to be identified. He stated that December is not a good month for "this". Scott answered that ICPD is prepared to brief anyone before the holiday break. Elisabeth added the 15<sup>th</sup> of January would be a hard deadline for coaches and speakers so they can be properly prepared for the upcoming workshop. Walter wants to make sure the coaches and speakers have enough time to digest the primers.
