## Welcome remarks & introductions:

Scott May welcomed the committee members to the Scientist Mentoring and Diversity Program for Biotechnology (SMDP Biotech) Outreach & Planning Committee. Scott directed the committee members to locate the agenda and supporting documents for the meeting on the ICPD website <u>www.icpdprograms.org</u>, select "Committees" from the "Select an ICPD site" drop-down menu at the top right side of the page. Scott then invited everyone on the call to introduce themselves. Scott reviewed the agenda for the meeting.

## Planning the 2018 SMDP Biotech Training Session (June 2-6, Boston)

- Incoming Scholar group Number and description; Orientation call May 17<sup>th</sup> at 2pm EDT; Confirmed sponsorships of 30 scholars; 4 additional sponsorships pending Scott noted that we have a fabulous group of Scholars. There will be 30 scholars. Dustie shared that about 75% of the scholars are female and that all the scholars represent a wide variety of universities from across the country.
- <u>Incoming Mentors Orientation call May 17<sup>th</sup> at 3pm edt; Identification of 12 mentors pending</u> Scott mentioned about half of the mentors have been identified. We are hoping to have all of them firmed up by the end of the week. Their orientation call will be May 17 at 3pm Eastern.



#### • Program Agenda and Speakers

Elisabeth explained that we have made great progress on the training session that kicks off on June 2. We have almost all the speakers confirmed. She reminded the committee that the training kicks off on June 2 with a "Celebration and Diversity Reception" in the evening. Our master of ceremonies will be Dr. Josh Ghaim, Chief Technology Officer, J&J Consumer Healthcare. Aine Hanly, Vice President Drug Substance and Site Head, Cambridge, will be the keynote speaker. Aine has been a mentor in the past and a great role model for the scholars. Sunday June 3<sup>rd</sup> is a full day of training. It will include a session with Julie Campbell about social media, discussions to help the scholars prepare for their careers and sessions with talent acquisition Professionals. The end of the day will be a discussion about resumes. Sunday evening will be an informal dinner and gives an opportunity for the scholars to spend time with their mentors. Monday's training will include an alumni panel. We are being hosted by Amgen Cambridge. After the training we will have a site visit to J&J Innovation and J-Labs. They scholars will go to the convention in the afternoon to register for the BIO International Convention (BIO). Elisabeth mentioned we are looking for a moderator for the Career Choices Panel. She thanked the committee for assisting with identifying speakers.

<u>Celebration of Mentoring and Diversity Reception – Saturday, June 2, 6-9 pm, MIT Museum, all welcome</u>
 Scott noted that the reception is the evening of Saturday, June 2<sup>nd</sup> at the MIT Museum.

The event includes a one-hour networking reception, an hour for various presentations and keynote speaker, and ending with dessert and coffee. The keynote speaker will be Aine Hanly, former mentor and Vice President Drug Substance and Site Head, Amgen Cambridge, and the Master of Ceremony will be Josh Ghaim, Ph.D., Chief Technology Officer, at J&J Consumer Healthcare.

- <u>Updates on BIO International Convention; Discussion item-pop-up meetings recommendations</u> Scott shared that Ed Shipley is unable to make the meeting due to travel but passed on a message to be shared today. "BIO 2018 is looking exceptionally good." Scott explained that BIO is a great way for the scholars to learn about industry. It is an efficient way for them to time for networking. Scott asked the committee to email him if they know of any colleagues who will be at BIO and who would be interested in having a "pop-up" meeting with the scholars. These are informal "stand-up" meetings held in the exhibit hall or near registration. The scholars can give their elevator pitches and the company senior leaders can do the same.

  - <u>Recent Webinars "J&J Early IN Career Talent Programs," March 8</u> This was a well-attended webinar. It was our first "sold out" webinar. We are able to have 25 participants in full interactive mode or 50 with interactivity limited to the Q&A periods. Dustie is working on how to accommodate and expand the numbers for future webinars.

Elisabeth said we are launching monthly email updates to current scholars and mentors to provide them with guidance about how to have a productive mentor/mentee relationship.
